This is What Democracy Looks Like...

- When a record number of voters make it to the polls for the midterm election.
- When LWVMI members from almost all of the 33 Leagues gather more than 23,000 signatures to get Promote the Vote 2022 on the November ballot as Prop 2.
- When LWVMI members hold presentations to explain all three-ballot proposals.
- When LWVMI members participate in presentations, media events that include press, TV and radio to promote Prop 2 and 1 and 3.
- When all three of those ballot proposals PASS overwhelming by Michigan voters showing that Michigan voters want good policy.
- When LWVMI members volunteer to be poll workers and poll challengers and observers to ensure the integrity of our elections.
- When LWVMI members produce an online voter guide for sound election information.
- When that online voter guide is printed and distributed to underserved communities.
- When more than 250 League and coalition partners volunteer to observe the County Board of Canvassers election certification process and witness no interference by bad actors.

 When Washtenaw, Lansing, and Kalamazoo Leagues send members to help with student registration and voting at U of M, MSU, and Western Universities at the prompt of a phone call on election night.

- When LWVMI members drive people in those lines to their correct polling locations.
- When those students wait, in some cases more than 5 hours, to register and vote so their voices can be heard.
- When the independent redistricting commission really puts an end to gerrymandering and voters' voices are actually heard.

Democracy in Action

There are 83 counties in Michigan, and a 4-person Board of Canvassers (BOC) in every one of them meets within 48 hours after each election to review the precinct paperwork and then certify the elections in their counties. League members from across the state have stepped up to help us accomplish the goal of our BOC Observer project: to

watch democracy in action as the Board members examine poll books, tapes, and sealed envelopes, and to identify anything peculiar or suspicious that might be a preview of trouble ahead for the final certification.

LWVMI's BOC Observer program has received statewide and national attention because of its thoroughness and revelations about what is happening at the county level following elections. The success of the program is owed to all of the observers who have put in 2, 4, 6 and sometimes 8-hour shifts to watch the often tedious process of making sure that every vote that was cast in the election is counted. At this writing, we have received over 300 shift reports from our observers, and 60 counties have certified. We thank Sara Weertz, our project manager for helping us stay organized during these past few weeks, but especially all of our observers who have done such a wonderful job of keeping us informed about what's going on in each county.

At this writing, we have received over 300 shift reports from our observers, and 63 counties have been certified. The deadline for certification is Tuesday, November 22. The State BOC's certification meeting is set for 10 a.m. on November 28 at Delta Township Hall. We expect there to be a zoom link available, but it has not been announced yet.

LWVMI invites all observers, and others who are interested, to attend a BOC Observer Debriefing call on Thursday, December 1, at 7 p.m. Anyone who turned in a shift or certification report will receive the link on Nov. 28. If you do not receive it, please contact me paulabowman9000@gmail.com

We can't repeat our gratitude to our BOC leaders and our observers enough for making this project a success. Thank you, thank you, thank you!

Voter Services News

November 8, 2022 has come and gone. What an incredible election it was! A large voter turnout, especially among young voters! Three very important ballot initiatives passed!

Michigan experienced a record number of voters (4,485,779) for the midterm election. Based on voting age population, the 2022 midterm was the highest voter turnout on record at 56.8%

Over 2 million absentee ballots were requested, with 85% returned. This is a 52% increase from 2018, when just over a million ballots were requested. Half of those absentee ballots were from voters over age 65, with 5% from the 18-24 year old age group; 57% were from women.

A sincere thanks to all local League members who committed to election work, whether it was registering new voters, conducting candidate forums, providing information on candidates for Vote411, distributing paper voter guides to their communities, Get Out the Vote (GOTV) efforts (writing postcards, text banking, etc.), working the polls as either an election inspector, AVB counting board, challenger or observer, and also traveling to busy precincts (including college campuses) on Election Day to assist with last minute registrations and voting. All of your efforts paid off, resulting in a smooth election process with few incidents or problems.

2022 Election Report: At a Glance

The 2022 midterm elections demonstrated the power of women, young people, people of color, and all voters who care about democracy.

Across the country, the League of Women Voters powered the elections. 750+ state and local Leagues registered voters, trained volunteers, served as poll workers, and organized to get out the vote!

The following data represents a snapshot of our impact in the 2022 midterm elections as of November 10, 2022.



At the November 17, 2022 Vote411 Admin Celebration, the following information was provided for the period January 1-November 8, 2022. We will receive the final data specific to Michigan soon and will share it with the membership.

- Total users 4,666,859
- Total sessions 5,955,120
- Page Views 21,185,594
- Number of candidates 52,397*
- Number of races 27,906*
- Number of admins 913
- Number of guides 304
- Number of states 43
- Younger engagement on Vote411 55% (ages 18-44)
- Women accessing Vote411 54%

*The number of candidates and races is a 100% increase over activity during the 2018 election cycle.

There will be no Voter Services Team meetings in November and December. A special thanks to all who participated this year and shared so many great ideas, suggestions, and challenges. I will send a schedule for 2023 after the first of the year.

Advocacy Updates

The election has finished and now we see the impact of the proposals that were passed and the people who were elected.

The Michigan House of Representatives now has 56 Democrats and 54 Republicans, and the Michigan Senate has 20 Democrats and 18 Republicans. The Governor, Secretary of State, and Attorney General are also Democrats. This means the two branches should work together. This is the first time the Democrats have been in charge since the election of 1982. However, it was short-lived when two Democratic Senate members were recalled in 1983.

The new leadership in the Michigan Senate will be Senate Majority Leader Winnie Brinks (D-Grand Rapids) and Senate Minority Leaders Aric Nesbitt (R-Lawton).

The Michigan House leaders will be House Speaker Joe Tate (D-Detroit) and House Minority Leader Matt Hall(R-Comstock Township).

There will be an increase in women serving. There will be 15 women (12D, 3R) in the MI Senate, and 45 women (33D, 12R) in the Michigan House.

There will be 14 Black members of the Michigan House of Representatives, the same as this session. There will be 3 Black members of the Michigan Senate, two less than this session.

The Governor will be announcing her priorities during the State of the State Speech in late January 2023. The Michigan House of Representatives and Michigan Senate will be setting their agendas and making committee assignments. According to a story in the Detroit Free Press and USA Today Network, the agenda may include changes in Right to Work, abortion, gun laws, taxes and spending priorities, third-grade reading law, equality under the law, and ethics reform.

The three ballot proposals that passed go into effect 45 days after election day. There will be implementation issues for all three proposals.

- The House and Senate must pass legislation as required by Proposal 1, Transparency and Term Limits, to implement the transparency program for certain elected officials.
- On Proposal 2, Promote the Vote 2022, they will need to implement and fund some of the new initiatives, such as 9 days of early voting and state-funded absentee-ballot dropboxes and postage of absentee applications and ballots.
- On Proposal 3, Reproductive Freedom, they may want to change some of the current regulations such as the 24-hour waiting period,

etc. The LWVMI Advocacy Committee is prepared to follow any proposed legislation.

Currently, the Michigan Senate and House are scheduled to return on November 29. It is unclear what the agenda will be. All introduced legislation will die at the close of the two-year session on December 31, 2022.

We will also be watching for a report from the Secretary of State on the two initiative petitions, Secure MI Vote and Let MI Kids Learn. <u>Click here</u> to see the current list of bills that LWVMI has taken a position on.

Approved, and Now Voted On - What We've Learned After the First Election Under Michigan's New Redistricting Process

LWVMI is a co-sponsor of this virtual forum on November 30, 2022, from 7-8:30 p.m., conducted by the Ford School at the University of Michigan as part of its CLOSUP Lecture Series.

Michigan's new approach to redistricting by an independent citizens commission has now come full circle, from signature gathering for the statewide ballot initiative in 2018, to strong statewide support in that fall's election, creation of the Michigan Independent Citizens Redistricting Commission, their work drawing new districts with extraordinary input from Michigan citizens, and now the new districts being used for the first time in the 2022 elections.

MICRC Update

MICRC Meeting Highlights

The Commission's next scheduled meeting is December 15, 2022, from 10 a.m. - noon. The MICRC will determine its 2023 meeting schedule at the December meeting. Members of our League Monitoring Team continue to observe and report on the meetings.

MICRC Budget

Note: State fiscal year ended September 30.

FY 2023: MICRC approved budget: \$3,169, 825, (25% of Sec. of State budget as required by the Michigan Constitution), includes salaries for 13 commissioners at 25% of Governor's salary, also required by the Michigan Constitution.

MICRC budget was not included in the recently approved state budget, nor in the Supplemental Budget. Executive Director Woods' meeting with Legislative Services was unsuccessful in persuading Legislature to provide the required funding.

Next week, Executive Director Woods and MICRC attorney David Fink will meet with each of the current House and Senate Appropriations Committee Chairs to discuss the possibility of funding the MICRC in a 2022 Supplemental Budget appropriation bill.

If those meetings are not successful, the MICRC has authorized Executive Director Woods to take all steps necessary to resolve the issue including litigation. Attorney David Fink has stated he believes the impasse is the result of legislative misunderstanding, and that once this is cleared up, the Legislature will do the right thing and appropriate the funds. Of course, if they don't, then litigation will be pursued.

Reports

The "Lessons Learned" video was approved by the Commission. I recommend League members watch it. The video is posted on the Michigan.gov/MICRC website, along with other meeting materials for October 27, 2022.

Update on two lawsuits, both in the federal courts

Agee et al v. Benson et al filed in Western District Federal Court, claims MICRC violated VRA when it drew state House and Senate maps in SE Michigan. Oral arguments will be heard in late summer/early fall of 2023; whether or not the case will go to trial will be determined by the Court after the oral arguments are heard. Justice Maloney, who is handling the current process, has asked the Secretary of State for deadlines related to the 2024 election.

A U.S. Supreme Court decision on the Alabama Redistricting Case, which claims that Section 2 of the Voting Rights Act is unconstitutional, could impact the Agee lawsuit. That decision is expected after the first of the year. Banerian v ICRC and Benson, filed in Federal Court of Western District: Claims MICRC's U.S House map (Chestnut) violates U.S. Constitutional requirement of one person, one vote plus claims of Community of Interest violations. Requests injunction.

- Community of Interest claims dismissed by the court as non-judiciable under "Rucho", March 4, 2022,
- The request for preliminary injunction denied March 4, 2022.
- One person one vote claim denied March 25, 2022

Plaintiff appealed the denial of the preliminary injunction to U.S. Supreme Court.

November 7, 2022, U.S. Supreme Court dismissed the request for preliminary injunction as moot. No other issue was before the Court. The case is still alive. It's up to the plaintiffs to decide if they want to pursue it further.



Remembering Eva Packard

We are sad to report that Eva Packard passed away on September 29, 2022. Eva was a long-time LWV member, first with Detroit and then with the Oakland Area League, and had served on the state board for more than 10 years. Serving as Voter Services Director starting in 2009, she was



LWVMI's first coordinator of VOTE411. Those were challenging years for all

Leagues as we worked to embrace the new technology in the voter services realm, but Eva's career experience in computer operating systems made her the perfect person to guide not only LWVMI but also local Leagues through this new VOTE411 platform. Eva eventually wrote a "how-to" manual for VOTE411 that was even used at the LWVUS level. For several elections, Eva managed both VOTE411 and the printed voter guide herself, a huge responsibility.

Besides her technology skills, Eva paid attention to details like no one else. She reviewed every board report with keen eyes and asked questions that were on no one else's radar. During the years that I was *Voter* Editor, she was among those who would receive an advance copy to proofread. I'd brace myself when I'd get her review because she would always find things that needed correcting. Embarrassing as it often was, I convinced myself that her proofreading made me a better writer and made the state *Voter* a better publication.

Eva lived near me, and we would often drive to the monthly board meetings in Lansing. We learned a lot about each other during these trips, and I treasured her friendship. Eva was born in Budapest and emigrated to the US with her family when she was very young. During her work life at GM, her talent for detail led her to be hand-picked by GM's leadership to be one of the first women in their computer technology training program. Eva was also politically astute and understood the fine line between non-partisanship and advocating for the progressive policies of LWV. We are a better League because of her service; she will be missed.


Local League Spotlights


