Strategic Planning

The state board has been involved in a *strategic* planning process for the past couple of months. We expect to have a plan together after the February board meeting. This plan will be our guide for the next two years and will be on our website. We have been guided through this process by Joan Sampeiri, past president of LWV Washtenaw. Some of you may groan at the mere



thought of strategic planning, but Joan is making the process far less painful.

On that note, I am not advocating for local Leagues/Units to go through the involved strategic planning process, but to do a **SWOT analysis**. That is a self-analysis process to identify your **Strengths**, **Weaknesses**, **Opportunities and Threats**. This is a wonderful opportunity to assess what you have accomplished; what you meant to do; what you would like to do and the problems that could occur if you do not do something or at least develop a committee to examine feasibility.

Once you have completed the **SWOT** exercise, planning your activities/calendars for the year will fall into place more readily. (Except when there is a state advocacy initiative or voter service program!). Being armed with that information also contributes to budget planning for your

annual meetings. Your nominations committee has more information to find the skills to help with your new goals.

The process is not painful and can even be fun. There are a multitude of ways to go about this. For example, the board can do a **SWOT analysis**, or each committee and engage members that are interested to go through the process. Then the activity planners should actually follow through on putting items on your League/Unit calendar. You will find out how your plans for the year develop around your voter service activities. This can be especially helpful in a year with an election cycle less active.

19th Amendment Project: Work on this project began this month, with our 8 volunteers in contact with the Muskegon 4th grade teachers. Several

volunteers have interacted with the teachers and students to provide their expertise on what and how the League is and provide them with our perspectives on the 19th Amendment and suffrage movement. The book assigned to the students, *The Hope Chest*, by Karen Schwabach, includes period photographs, historical notes about the suffrage movement, a "Voting in America" timeline and other activities. MI Vote Matters High School Registration Challenge

The Spring 2023 MI Vote Matters High School Voter Registration Challenge is now open! School participants in the Spring 2022 challenge will be

automatically enrolled for the Fall challenge. In addition, there are currently 11 new schools signed up for 2023. If you know of new schools who want to sign up, they can use this link: inspire2vote.org/MIVoteMatters.

This year, team captains will be selected at each school to assist with peer-to-peer voter registration efforts. Once again, we will be asking our Voter Services team members to work with the team captains at schools within our local League boundaries. Further details will be forthcoming.

The next Voter Services virtual team meeting will be held on Thursday, January 26, 7:00 p.m. We will review our goals for the year and also hear from guest speaker, Lindsay Maas, Director of Field Strategies and Data, Michigan Voices. She will discuss the Voter Access Network (VAN), what it is, how it works and how local Leagues can benefit. She will also provide data from the 2022 election. The Zoom link will be sent to team members the day before the meeting. As always, the meeting will be recorded for those who cannot attend.

Advocacy

The 101st legislative session came to an end. In the 2021-22 Legislative session, 3,733 bills were introduced in the House and Senate, 407 were signed into law and 61 were vetoed by the Governor. About 11% of the bills became laws



with a divided government. In the 2017-18 legislative session, 3,879 bills were introduced in the House and Senate, 957 were signed into law and 63 vetoed by the Governor. About 25% of the bills became laws with a Republican Legislature and Governor.

The three ballot proposals went into effect the end of December. In addition, Secure MI Vote, Let MI Kids Learn and Raise the Wage turned in signatures on their petitions for initiatives. On December 28, Secure MI Vote and Let MI Kids Learn withdrew their petitions for consideration. The Michigan Election Bureau is currently reviewing the signatures gathered for the Raise the Wage initiative petition. The Raise the Wage initiative to amend Michigan's law would raise the state minimum wage to \$15/hour, and end subminimum wages for tipped workers, workers with disabilities, and youth. If approved by the Bureau of Elections and the State Board of Canvassers, it would go to the Legislature for adoption. If not adopted by the Legislature it goes on the 2024 ballot for the voters to decide.

The new session, the 102nd, was called to order on Wednesday, January 11, when members were sworn in, leaders were elected and rules were adopted. Senate Majority Leader is Senator Winnie Brinks (D-Grand Rapids)

and the minority leader is Senator Aric Nesbitt (R- Porter Township). The House of Representatives Speaker is Joe Tate (D-Detroit) and the Minority Leader is Representative Matt Hall (R-Kalamazoo). The House and Senate have assigned members to committees. For information about the legislative session, please go to www.legislature.mi.gov.

The Governor has scheduled the State of the State for January 25, at 7 p.m. Two top priorities are passage of the earned income tax and the repeal of the income tax on pensions.

On January 17, Secretary of State Jocelyn Benson and a group of House and Senate members announced their intention to work on legislation that would protect election workers. Benson and state lawmakers announce plans to protect the people who protect democracy (michigan.gov) No bills have been introduced yet. SOS Benson also announced the formation of an elections policy working group to suggest, review, and provide feedback on election policies on a rolling basis. The group will be comprised of nonpartisan pro-democracy organizations; Republican, Democratic and nonpartisan clerks; the chairs of both legislative elections committees; and representatives from the Executive Office of the Governor.

The LWVMI Advocacy Committee will develop the questions for legislative interviews at its February meeting and after board approval local Leagues will be getting packets. This is an opportunity to meet with your elected officials to hear about their priorities and discuss issues.

LWVMI Supports National Popular Vote Compact

Election of the President

The League of Women Voters has supported direct election of the President of the United States since 1970.

"The League of Women Voters of the United States believes that the Electoral College should be abolished. We support the use of the National Popular Vote Compact as one acceptable way to achieve the goal of the direct popular vote for the election of the President until the abolition of the Electoral College is accomplished". *Impact on Issues, 2020-2022.*

National Popular Vote (NPV)

If Michigan joins the National Popular Vote Compact, Michigan's presidential Electors would cast all their votes for the candidate who won the most popular votes for President in all 50 states and the District of Columbia.

The Compact will go into effect when the number of states in the Compact possesses 270 electoral votes, which is the number required to elect the President. The NPV bill has passed in 16 states. The Compact currently possesses 195 electoral votes; 75 more are needed for the Compact to go into effect. Michigan has 15 electoral votes.

LWVMI Board Action

On December 10, 2022, the LWVMI Board took the following action:

1. Approved signing on to a letter to state legislators indicating LWVMI

- support of the National Popular Vote
- 2. Approved joining the Coalition in support of the NPV legislative campaign.

Susan Smith, Advocacy VP, will represent LWVMI in the Coalition.

Opportunities for Local League Action

LWVMI encourages local Leagues and state Units to educate their membership and their communities about the NPV Compact. LWVMI will provide NPV materials for use in Town Halls and/or zoom webinars. Training will be provided for local League and Unit Presenters. Educational events should be scheduled for February, March or April since the NPV bill will be introduced in the Michigan Legislature this Spring. Contact your local League or state Unit for more information.

MICRC Update

Meetings

The MICRC meets virtually the third Thursday of each month. The next meeting will be February 16 at 9 am. Members of our League Monitoring

Team continue to observe and report on the meetings.



MICRC Funding

The MICRC filed a Summary Complaint against the Michigan House and Senate in the Michigan Court of Claims on December 13, 2022 seeking full funding of the MICRC (\$3.17 million) as required by the Michigan Constitution.

On January 17, 2023, Senate Democrats passed \$1.5 million for the MICRC in a supplemental bill which now has to go to the House and be signed by the Governor. The MICRC has \$431,994 in outstanding expenses for the current fiscal year which began October 1, 2022.

Edward Woods, III, MICRC Executive Director, continues to meet with Michigan legislators and the administration to secure the additional funds as required by the Michigan Constitution. He and the Commission are hopeful that an agreement can be reached out of Court.

Dormancy and Reactivation Plan

On January 19, 2023 Commissioners approved the Dormancy and Reactivation plan that Commissioners Clark, Lett and Szetela have worked on for the past 8 months. The plan is posted on the MICRC website along with other December 15, 2022 meeting materials.

In addition to providing a process for the handling of computers, cell phones and documents, the plan includes the following:

- Commission will move to dormancy status when all litigation against the MICRC is completed. (Only one lawsuit, Agee v Benson) remains.)
 Commission members will not be paid during dormancy.
- If litigation is filed when the Commission is dormant, the Secretary of State will reconvene the Commission. Members will receive salaries as provided by the Michigan Constitution.

 Terms of the current Commissioners end upon appointment of succeeding MICRC in 2030.

Update on two lawsuits, both in the federal courts

Agee et al v. Benson et al filed in Western District Federal Court, claims MICRC violated VRA when it drew state House and Senate maps in SE Michigan. Oral arguments will be heard July 12, 2023. Whether or not the case will go to trial will be determined by the Court after the oral arguments are heard. Justice Maloney, who is handling the current process, has asked the Secretary of State for deadlines related to the 2024 election.

Depositions are being taken. Commissioners as well as current and former staff will meet with MICRC attorneys the first week in February 2023.

A U.S. Supreme Court decision on Alabama Redistricting Case, which claims that Section 2 of the Voting Rights Act is unconstitutional, could impact the Agee lawsuit. That decision is expected after the first of the year.

Banerian v ICRC and Benson, filed in Federal Court of Western District: Claims MICRC's U.S House map (Chestnut) violates U.S. Constitutional requirement of one person, one vote plus claims of Community of Interest violations. Requests injunction.

- Community of Interest claims dismissed by court as non-judiciable under "Rucho", March 4, 2022,
- Request for preliminary injunction denied, March 4, 2022.
- One person one vote claim denied March 25, 2022

Plaintiff appealed denial of preliminary injunction to U.S. Supreme Court.

On November 7,2022, the U.S. Supreme Court dismissed the request for a preliminary injunction as moot. No other issue was before the Court. On January 14, 2023, the case was dismissed at the request of the Plaintiffs.

Moore v Harper, North Carolina Redistricting Case

This case, which is before the U.S. Supreme Court, is based on the "Independent State Legislature Theory", which states only state legislatures have the authority to draw up rules regarding federal elections, including drawing the lines for Congressional Districts. State courts and Governors have no role in the process. Oral arguments were heard on December 7,2022. A decision by SCOTUS is expected in June 2023.

LWVMI joined the LWVUS Amicus Brief in opposition to the Independent State Legislature Theory.


