LWVMI 2023 Convention

Our 2023 LWVMI Convenion will be held on May 19-21, 2023 at the Kellogg Hotel and Conference Center in East Lansing, Michigan. This year's inperson Convention promises to be informative, productive and fun. State Convention provides us with an opportunity to conduct the important business of the state League and create and renew friendships with League members across the state. Unfortunately, there is not a virtual option.

Delegates will:

- Adopt the 2023-2025 state program, including any state studies
- Adopt the LWVMI budgets for the next two years
- Elect LWVMI officers and members of the Board of Directors
- Consider amendments to the LWVMI bylaws, if proposed

Remember that **any** member can attend the convention – whether they are a voting delegate or not. Here are some of the details so far:

Timeline

Friday: Optional pre-convention activities in the afternoon and a "dine around" in the East Lansing/Lansing area. The first Plenary is at 7:00 pm.

Saturday: Breakfast followed by 2nd Plenary. Lunch, then afternoon workshops, Awards Banquet in the evening (our banquet will be held in the MSU "Club Room" overlooking Spartan Stadium!)

Sunday: Breakfast and 3rd Plenary. Should wrap up by 11:00
