The four transformation workgroups are winding up their sessions with the information gathered to be reviewed and assessed by consultants. This aggregate will be discussed at the total workgroup review meeting in early May.

### **Voter Services**

### **May 2 Election Reminders**

- Michiganders who want to vote in the May 2 election in their community have less than one week left to register to vote <u>online</u> or by mailing a <u>paper application</u> to their city or township clerk. Beginning April 18, Michiganders must register to vote or update their registration in person at their city or township clerk's office with proof of residency to vote in the May election. Visit Michigan.gov/vote for more details on registering to vote.
- Voters who wish to vote from home before the May election, but who
  haven't yet applied for an absentee ballot, are encouraged to apply for
  a ballot <u>by mail</u> or <u>online</u> as soon as possible to ensure they have
  sufficient time to receive the ballot, complete it, and return it to their
  city or township clerk.
- Voters may also vote before Election Day in person at their city or township clerk's office using an absentee ballot. Voters can go to <a href="https://mvic.sos.state.mi.us/">https://mvic.sos.state.mi.us/</a>, click on "your voter information" and enter the required information to see their clerk's hours and location(s), and whether there's a May election in their community.
- Visit <u>MichiganVoting.org</u> for more details on voting before Election Day.

### **Campaign Finance Reform Lobby Day**

Come join League members and other concerned citizens for a Campaign Finance Reform Lobby Day on Thursday, April 27, 9 a.m. - 4 p.m., at the Capitol in Lansing. There will be opportunities for you to meet with your Representative and/or your Senator. Meetings will be organized in advance by the Lobby Day planning team, and you will be notified of your time slot ahead of time.

You are welcome to come for the whole day or half a day, depending on

your schedule. There will be a Press Conference at noon and Lunch at 1 p.m.

Two identical, virtual training opportunities will be available; you can sign up when you register to attend Lobby Day.

- Friday, April 21, 1:30-2:30 p.m.
- Monday, April 24, 6-7 p.m.

Talking points for your meeting with your Legislator will be provided. We are not lobbying for a specific bill at this time. We are advocating for increased transparency and asking legislators to support campaign finance reform.

### **Citizen's Guide to State Government**

### **Action Alerts**

LWVMI has been sending out Action Alerts. We urge you to open the emails and email your legislators when asked. You can edit the letters. It is important that legislators who support as well as oppose our legislation hear from constituents. Remember the other side is contacting them so it's important both sides participate. You can also check out all of our action alerts at the LWVMI website under the Take Action button.

### **Update on State Laws**

Governor Whitmer signed into law, Public Acts 11, 12, and 13 of 2023.

- PA 11 repeals sections 14 & 15 of PA 328 of 1931 (MCL 750.14 & 750.15) that provide a penalty for administering with intent to procure miscarriage and advertisement or sale of certain drugs.
- PA 12 repeals section 40 of the Michigan Penal Code (MCL 750.40) that makes it a misdemeanor offense to publish or sell in Michigan a circular, pamphlet, or book that contains either of the following recipes for abortion or contraception.
- PA 13 repeals the sentencing guidelines for a crime of administering drugs to procure a miscarriage, sec. 16a, ch. XVII of <u>1927 PA</u> <u>175</u> (MCL <u>777.16a</u>).

Governor Whitmer signed into law Public Acts 14, 15, 16, 17,18, and 19 of 2023 that will require background checks and safe storage of firearms. The Michigan House of Representatives also passed the Red Flag bills, HBs

4145-49 and SB 83 and sent them to the Senate. So far, the passage of this legislation has been supported by Democrats with little or no support of the Republicans. None of this legislation has been given immediate effect, so they will go into effect 90 days after this year's session ends.

### **Abortion Prescription Access**

April 7, Federal District Court Judge in Washington State, Thomas O. Rice, grants a request from 17 states and D.C., *State of Washington v FDA* to block FDA from making changes to mifepristone's access in the states that sued. The states that sued the FDA in Eastern Washington are Washington, Oregon, Arizona, Colorado, Connecticut, Delaware, Illinois, Michigan, Nevada, New Mexico, Rhode Island, Vermont, Hawaii, Maine, Maryland, Minnesota and Pennsylvania, and Washington, D.C. Governor Whitmer also issued a press release saying mifepristone is available in Michigan.

### **National Popular Vote**

Between now and the summer recess, LWVMI is working to make sure the National Popular Vote bill passes in the House and Senate. Also, we are anticipating legislation to be introduced to implement Promote the Vote 2022, pay equity, and campaign finance

### **Healthy Climate Conference**

Michigan Gov. Gretchen Whitmer was the keynote speaker at the sold-out MI Healthy Climate Conference held in Detroit on April 11 and 12. The conference was organized to focus action on how to protect Michigan from the most significant impacts of climate change, while seizing the economic opportunities of a clean energy transition.

The <u>two-day conference</u> brought together nearly 600 stakeholders from across the state and nation to help implement key actions in the <u>MI Healthy Climate Plan</u>. The conference was organized by the State of Michigan through the Michigan Department of Environment, Great Lakes, and Energy (EGLE).

The MI Healthy Climate Plan released last year, outlines strategies for slashing Michigan carbon emissions by 52% in 2030 and developing a carbon-neutral state economy by 2050. These strategies included:

- · Making our buildings more efficient
- · Expanding the use of electric vehicles
- Generating power from renewable sources and
- · Focusing funding in disadvantaged communities.

The MEMJ (**M**ichigan **E**nergy, **M**ichigan **J**obs) Coalition, a coalition of environmental groups rallied before the Conference to urge Michigan lawmakers to take action to fight climate change.

Specifically, the Coalition called on state lawmakers to:

- Pass a standard requiring 100% of Michigan's energy to be carbonfree by 2035.
- Create energy conservation policies to save money for customers and drive down pollution related to power generation.
- Allow and require the Michigan Public Service Commission to hold utility companies accountable for the equity, health, affordability and climate impacts of their operations.

The Coalition also supports community solar access, which would allow people to buy shares of nearby solar installations and be credited on their power bills for their portion of renewable energy.
