

## **Another BOC Observation Program** in the Books

Approximately 400 hours were spent by League members at the post-election observation of the Boards of Canvassers. All 83 counties were either contacted in person or by phone to verify certification of the February 27 election, and the

Michigan Board of Canvassers certified on March 18. This was the first election where statewide early voting was a requirement, and though it added an extra layer of work for the canvassers, this obstacle was handled within the deadlines. The August, and especially the November elections will pose more challenges. We appreciate all the time and assistance from all League

members who helped with this important part of the election process.

#### **Voter Information Brochure Available**

The 2024 Voter Information Brochure is complete and available in English, Arabic and Spanish versions. Although it's not a glitzy, fancy brochure, it contains updated information on new voting rights, based on the passage of Proposal 2 of 2022. We were fortunate to receive assistance with the translation from the Empowered Community Outreach Services (ECOS) in Detroit (Arabic), and the Hispanic Center of Western Michigan (Spanish). All three versions are available on our website at LWVMI.org in the LWV Only section. We hope local Leagues will share the brochures within their communities, as well as post on their websites.

#### **Election Worker Survey**

Did you work during the February 27th Presidential Primary Election as a poll worker/election inspector, observer or challenger? We hope you will take this quick survey so we have a record of your work. So far, 76 people have completed the survey, but we know there are many more of you out there who worked either during early voting or on Election Day. Please help us gather this data for our donor reports and so we know how many of our local League members participate in this very important process. And thanks to all of you who worked at early voting sites and on Election Day!

#### **High School Presentation Now Available**

We are pleased to announce a new presentation, with accompanying script, which is now available for local Leagues. This presentation includes those provisions of Proposal 2 of 2022 that our soon-to-be registered students need to know. We hope this is helpful as you schedule your high school registration events. #### **Advocacy Update**

#### **LWVMI Advocacy Committee Hosts Statewide Update**

#### **Update on Legislation**

<u>Firearm Safety</u>: On February 28, the Senate Elections and Ethics Committee reported HB 4127 and HB 4128 that will restrict firearms in election sites. Then the Senate passed the bills on February 29 by a vote of 20 (D)-18 (R). The bills are back in the House now. LWVMI supported these bills during the process. Governor Gretchen Whitmer announced Jennifer DeLaCruz as the director of the newly created Office of Community Intervention Services. The office was established to lead statewide efforts to reduce gun violence and save lives.

<u>Election Recounts</u>: On March 13, the Senate Elections and Ethics Committee took testimony on SB 603 and SB 604, modifying the recount process. Co-President Paula Bowman provided testimony in support of the bills, along with Promote the Vote and others. The testimony can be seen <u>here</u>.

<u>Freedom of Information Act</u> On March 13, the Senate Oversight Committee reported bills, SB 669-SB 670, that LWVMI supports that would put the Legislature and the Governor's Office under the Freedom of Information Act. These bills will greatly increase transparency in government. An action alert was sent to all LWVMI members on Friday, March 15. If you missed it, you can still act now, by going to the <u>Take Action</u> button at LWVMI's website.

MI Voting Rights Act We anticipate hearings in the Senate Elections and Ethics Committee during the spring on the MI Voting Rights Act, SB 401-404.

<u>Financial Disclosure</u>: On March 15, Secretary of State Benson announced a new portal where we can review the filings of elected officials' personal financial disclosures. This information was required to be submitted to the Secretary of State when voters passed Proposal 2022-1 and the MI Legislature passed Senate Bills 613-616 (PAs 281-284 of 2023). LWVMI supported the proposal and legislation. Elected officials must file the personal

financial disclosures by April 15 and candidates must file by May 15. You can see the information here.

<u>Lawsuit</u>: The Republican National Committee filed a<u>lawsuit</u> against Secretary of State Benson and the Elections Director in the U.S. Western District Court alleging that Michigan is not in compliance with the National Voting Rights Act that requires the voting registration rolls must be clean.

#### **MICRC Submits Final House Map to Court**

#### Final House Map Approved

On February 28, after holding two Public Hearings in Detroit on 10 draft proposed House maps, the Commission voted on the final House map. They approved the Motown Sound FC-E1 House map and sent it to the Court before the March 1, 2024 deadline. This map can be seen on the <a href="https://www.michigan.gov/MICRC">www.michigan.gov/MICRC</a> website.

Approval of the map required a majority yes vote of those Commissioners present including at least 2 Democrats, 2 Republicans and 2 Independents, as prescribed in the Michigan Constitution. The first vote failed when only 1 Republican voted for Motown Sound FC-E1. It was approved on the second round of voting: 10 to 3, when 2/4 Republicans, 4/4 Democrats and 4/5 Independents voted yes.

### Appeal of District Court's December 2023 Ruling to U.S. Supreme Court: MICRC Resolution

In addition to approving the final map, the Commission also passed a proactive Resolution, based on the advice of their Litigation attorneys. The Resolution prevents the Plaintiffs in the lawsuit from using the adoption of a final House map as an argument to the U.S. Supreme Court that the Commission's appeal was moot.

Note: On February 8, 2024, the Commission voted to file a 60-day continuation of their appeal. The MICRC can withdraw their appeal if they so choose.

#### **Court Appointed Special Masters**

The Drawing Special Master had to submit his House map to the Court by March 1, 2024.

The Reviewing Special Master had to submit his report on whether the Commissions map "lawfully remedies the constitutional violations identified in the Court's December 21, 2023 opinion and order" by March 15.

#### Plaintiffs File Objections to MICRC MAP

On March 8, the Plaintiffs filed their objections to the MICRC House map, asking the Court to reject the map.

They claim:

- 1. The remedial map prejudices Black voters by favoring incumbents elected under the unconstitutional and racially gerrymandered Hickory Plan.
- 2. The remedial state House map remains the product of race-based line drawing.
- a. State House Districts 16, 17 and 18 preserve the Commission's racially motivated "spoke concept".
- b. State House Districts 10 and 12 dilute Black voting strength.
- 3. The remedial state House map minimizes Black Opportunity, possibly in violation of the Voting Rights Act.

The MICRC had until March 15 to file their responses to the Plaintiffs' objections with the Court.

#### **Future Deadlines for House Maps**

March 20: deadline for both parties to file briefs on the Reviewing Special Master's Report.

March 29: deadline for Court to approve a "remedial House redistricting plan".

#### **Future Deadlines for Senate Maps**

The Court ordered the redrawing of the following six Senate districts: 1, 3, 6, 8, 10 and 11 and surrounding districts as necessary.

April 12: deadline for parties to "jointly submit a proposed timeline for preparing Senate remedial redistricting plan".

The redrawn Senate maps will take effect in time for the 2026 election.

She currently presents on native traditions and culture as well as consults with native and nonnative communities who are seeking to develop Peacemaking or wanting to live a balanced lifestyle.

JoAnne received her Business Administration degree from Ferris State University and a Juris Doctorate from the University of Wisconsin. Her professional experience includes one term on Tribal Council and as a Tribal Court Judge. She currently teaches a short course at NMC extended education twice a year, titled, History of the Anishinaabek.



With special guests from the Michigan Sierra Club leading the environmental conversation; Terri Wilkerson (LWV member), Stephen Brown, PhD, and Christy McGillivray along with AG Nessel

provided updates on the court proceedings regarding the closing of Line 5 through the Straits of Mackinaw. The AG welcomed everyone to join her in Cincinnati on March 21st to demonstrate support. Questions on PFAS contamination in our local waterways and how to report their findings, and election security in the areas of Artificial Intelligence and the security of local clerks and workers were also discussed in detail. The AG brought up the legality of Livingston County's 2<sup>nd</sup> Amendment Sanctuary status announced

by local government officials and how troubling and dangerous that stance is in protecting Livingston County residents. All of these topics and more, made for an educational evening, which you can view on the <u>Leagues YouTube</u> <u>Channel</u>. They invite you to share it with fellow members.
