# Congratulations, Convention, Canvassing and Communication

At the April 13 LWVMI board meeting, we were delighted to vote in favor of the application to become an independent League submitted by LWV of Lenawee County formerly LWV of Lenawee/Tecumseh. LWVLEN President Mindy Dunn, members Shelley Lim and Diana Fallot, along with their LWV Coach, Nancy Schewe, joined the board meeting and made the presentation. The application now goes to the LWVUS Board; we are confident of their approval!

Are you going? Anyone can attend the LWVUS Convention from June 28-30 in Washington D.C. Though local and state Leagues are only allowed a set number of voting delegates, a non-delegate can register as an observer. There's no doubt that in-person attendance has more benefits than participating online, but LWVUS knows that this is not doable for everyone or every League. LWVUS is making the online option available for the reasonable cost of \$125. We hope all Leagues in Michigan will be represented by at least one delegate either in-person or online. Visit the

<u>convention website</u> to get all the information and let your local President/Leader know if you are interested in attending.

Forty-six counties in Michigan have an election on May 7<sup>th</sup>. There are a lot of school proposals on the ballot, but also some special elections for school and township boards. We will again be activating our Board of Canvassers program, starting within 48 hours after each election. Our "Sign Up Genius" link will be available next week (gets better with each election!) and we hope that many members will sign up to observe a shift. Information from the reports submitted by the observers is reviewed by LWV leadership, as well as the legal staff of one of our democracy partners. If the report describes something of concern, those comments may even by elevated to the Department of Elections. There are many that depend on our reports and we're grateful for your help in this important work.

The final Spring workshop in our communications series is this Wednesday, April 24. We will hear from Sue Ellen Christian, a WMU Journalism professor, who will speak to us about mis- and dis-information in the media, especially in the new artificial intelligence space. <u>Click here to register!</u>

#### **New Resources for Voter Service Activities**

# **Advocacy Update**

Legislators returned from spring break and the special elections for the 13th House District and the 25th House District were held. Two Democrats won their respective elections. Mai Xiong won the 13th House District and Peter Herzberg won the 25th House District. By the



end of April, the elections should be certified and the House will have 56 Democrats and 54 Republicans.

#### **Update on Legislation**

**BRITE Act**: On March 14, during Sunshine week, a group of House Democrats held a press conference and introduced 7 bills, HB 5580-HB 5586, known as the BRITE Act, Bringing Reforms in Integrity, Transparency and Ethics. The bills were assigned to the House Ethics and Oversight Committee. LWVMI supports the bills.

On April 18, the House Ethics and Oversight Committee began taking testimony on HB 5583 to give the Secretary of State the authority to seek a court order to stop violations of the law, and HB 5586 to require legislators to wait one year from leaving office to become a lobbyist. Secretary of State Jocelyn Benson and Attorney General Dana Nessel testified in support. No vote was taken. More hearings will be held. Other bills would require any 501c4 or 527 organization affiliated with state officials and candidates to register those accounts with the Secretary of State's Office, include legislative staff under lobbying guidelines, and add disclosure of more gifts received by elected officials.

**Recount Legislation**: On April 18, the Senate moved SB 603 and SB 604, modifying the recount process, to third reading in the Senate. LWVMI supports these bills.

**Freedom of Information Act**: We are awaiting action in the full Senate on passage of SB 669 and SB 670 that would put the Legislature and the Governor's Office under the Freedom of Information Act. These bills will greatly increase transparency in government.

MI Voting Rights Act: We anticipate hearings in the Senate Elections and Ethics Committee sometime in May on the MI Voting Rights Act, SB 401-404.

**Financial Disclosure:** On April 15, information on elected officials' personal finances was made available on the Secretary of State's new <u>portal</u>. Candidates must file similar information by May 15.

# **Pillars of Civility**

Journalists Nolan Finley and Stephen
Henderson on March 22<sup>nd</sup> shared with over 50
League members the keys to civility they have identified after 17 years of conducting the
Civility Project. Holding differing political views,



the two editors often found themselves paired by the media with the expectation that they would disagree.

They did and still do disagree. And, they have formed a deep friendship and an understanding of how people can disagree without hating or trying to destroy each other.

- **1. Dropping assumptions** about why someone votes or thinks as they do.
- 2. Setting honest goals for the conversation. It's not a competition.
- **3. Active listening.** Reflect what you have heard to check your comprehension. Ask questions to deepen your understanding.
- **4. Keep coming back to the conversation.** Commit to staying in the challenging relationship. It's worth it, because civility strengthens societal institutions.

# Observer Corps News Light is Shone on Local Government

Deb Tyler, a League observer for the Genoa Township board of trustees, in Livingston County, certainly took this to heart recently. Her reporting informed the LWV of Livingston County of a situation with the Genoa Township Clerk regarding removal of voters from voter rolls. The removal resulted in a New York Times article, intervention by the ACLU, and notice from the Michigan Secretary of State. It also brought to light a group, Stand Up Livingston, whose purpose was to request that clerks remove voters from the Qualified

Voter File.

What follows is an unbiased observer corps summary of several meetings Deb observed....

I observed the Genoa Twp. Board meeting on March 18, 2024 and learned that township clerk Polly Skolarus had removed voters from the Qualified Voter File as requested by the group Stand Up Livingston. She said she did so per a 1954 law, and that she now had 500 challenged voters. She said she has to mail Return Receipt Requested notices to each voter at a cost of \$9 each. Clerk Skolarus brought this up at the end of the meeting under "Member Discussion."

At the April 1 township board meeting, Supervisor Rogers had added to the agenda "Review of ACLU press release and letter to the Township Clerk regarding improper removal of voters" and displayed the letter from the ACLU for all to see. Clerk Skolarus mentioned that she had a binder full of information from the ACLU, Secretary of State, Stand Up Livingston, allegations of voter fraud, articles from the New York Times, etc. She stated that she has complied with the requests from the ACLU, although Stand Up Livingston advised the board that the ACLU was out of line and that the clerk did not have to comply. Clerk Skolarus stated that no voter was denied the right to vote in February.

The Township attorney explained the laws and regulations for removing voters from the voter files, including proper mailings, and that he was concerned that these laws had not been followed. Clerk Skolarus was pointedly asked if she had sent out the proper mailings, and she said she hadn't because she doesn't want to spend the money.

The clerk mentioned that there was one person who voted twice in the February election. She said that the person had voted by absentee ballot, and then again at the polls in person. She said that the poll worker over-rode the poll book entry so the person could vote in person. She also said this happened 5 or 6 times in the State of Michigan. (This is still under investigation.)

I also attended the April 15 board meeting. During member discussion, the clerk was asked if she had met all the deadlines from the ACLU, and she stated she had not.

Deb's report is a noteworthy example of why the League needs an Observer Corps. Local governments should have a light shone on them, so the public is informed of what is being enacted in their communities. The League also needs to be aware, in case something arises which warrants additional action, as in the Genoa Township example.

When asked about her observer experience, Deb stated, 'I originally decided to observe Genoa Township because I live there. I almost didn't go to the March 18 meeting because nothing usually happens! I'm glad I decided to go anyway."

# **National Popular Vote: 61 More Votes Needed**

Last week, Maine became the 18<sup>th</sup> state to join the National Popular Vote (NPV) Compact. With Maine's four electoral votes, the combined electoral votes of those 18 states, totals 209.

The Electoral College has a total of 538 electoral votes. We need only 61 more to have 270, which is a majority of the Electoral College votes.

The League supports the National Popular Vote Compact because it ensures that each person's vote counts equally. The Presidential candidate who gets the most votes, nationwide, wins the election.

We support getting rid of the Electoral College for the same reason. Since abolishing the Electoral College requires passing an amendment to the U.S. Constitution, we can use the National Popular Vote Compact until that occurs.

When the Michigan Legislature passes the NPV bills, which are currently in House and Senate Committees, Michigan will add its 15 Electoral College votes to the Compact.

We know we have enough votes to pass the bills in both the House and Senate. We need the Leadership to bring them to the floor for a vote.

Later this month, LWVMI will send an Action Alert to all our members and supporters, asking them to contact their legislators and tell them we support these bills.

Please respond to the Action Alert. It's easy to do and takes only a few minutes.

The candidate who wins the majority of the popular vote nationwide, should win the Presidential election. That how democracy works!

# **Court Approves MICRC House Map**

### **Court Approves MICRC Final House Map**

The Federal District Court approved the MICRC's final House map, Motown Sound, on the advice of the Reviewing Special Master. The Court did not consider the House map submitted by the Drawing Special Master.

This was a real victory for the Commission and for the people of Michigan

who passed a ballot amendment giving the right to draw the redistricting maps to the citizens of Michigan.

#### **Court Ordered Redrawing of Senate Maps**

As part of their December 2023 ruling, the Federal District Court found the Senate maps for Districts 1, 3, 6, 8, 10 and 11 unconstitutional under the 14<sup>th</sup> Amendment of the U.S. Constitution because race was too big a factor when the MICRC drew the maps for those districts.

#### **Court Approved Senate Remedial Plan**

On April 15, 2024, the Court approved the Senate Remedial Plan that had been submitted jointly by both parties. The Court ordered the following timeline:

- May 22, Draft Proposed Maps due to the Court
- June 21, Public Comment on Draft Proposed Maps ends
- June 27, MICRC Final map due to Court
- July 5, Plaintiffs file objections to Court
- July 12, MICRC files response to objections with the Court
- July 12, Reviewing Special Master submits his report on Commission's work
- July 19, Parties may file briefs commenting on Report
- July 26, Court will adopt a remedial Senate district plan

Ordered MICRC to hold at least one Public Hearing in Detroit.

Agreed to delay decision on whether to appoint Special Drawing Master for Remedial Senate Districting Plan, as requested by the Commission.

Ordered MICRC to pay Drawing Special Master \$40,000 for his work in preparing the Remedial House Districting Plan.



- June 12, 10:00 am 3:00 pm and 4:00 7:00 pm
- June 13, 10:00 am 3:00 pm and 4:00 7:00 pm

# **Membership Leaders Network**

The Membership Leaders' Network on April 10<sup>th</sup> heard a presentation by JoAnne Cook, an active member of the Grand Traverse Band of the Ottawa / Chippewa Indians, on how to be an effective ally with the indigenous community. Her advice included the following:

- 1. Educate yourself about the history, culture, and issues indigenous peoples face.
- 2. Actively listen and amplify indigenous voices, share their work, and promote their initiatives.
- 3. Respect indigenous protocols and spaces: ask permission to participate.
- 4. Support indigenous-owned businesses and artists fostering economic empowerment.
- 5. Advocate for indigenous rights including land rights, clean water, access to quality healthcare and education.
- 6. Engage in reconciliation initiatives: attend workshops, cultural events, and volunteer with indigenous organizations.

To engage with indigenous peoples about voting, identify a member of the band that regularly communicates through a newsletter and offer to contribute an article on the topic. Start simply and expect that it will take time to build trust and interest that can lead to higher voter turnout.

This program was organized by Patty O'Donnell a member of the LWV of Leelanau County and the LWVMI DEI Team. There were several handouts including a Native American History Timeline, and a book list with the indigenous perspective that were shared with the recording that was sent to the Membership Leaders' Network. 

The LWV of Eastern Upper Peninsula hosted the Michigan Deputy Secretary of State, Aghogho Edevbie, on March 25<sup>th</sup> for a captivating public meeting at Lake Superior State University. He addressed topics pertaining to voting and actively responded to audience queries, offering insightful

perspectives on the democratic process.

The LWV of Leelanau County held its 2024 book read discussion on April 17<sup>th</sup> with the book, The Bill of Obligations – The Ten Habits of Good Citizens. The author, Richard Haass, is an experienced diplomat and currently president emeritus of the nonpartisan Council of Foreign Relations. He puts forward these 10 Habits as important for the future of US democracy.

The LWV of Grand Traverse Area celebrated "March is National Reading Month" with a program on "From Publication to the Public: A Library Book's Path to the Reader." Presenters included Michele Howard, Director of Traverse Area District Library, Stephie Luyt, Elementary Library Coordinator for Traverse City Area Public Schools, and Karrie Zeits, a governmental law attorney. Discussion included the process of publication, library selection, censorship and book banning.
