LWVUS Visit to Michigan

We were honored that LWVUS CEO, Celina Stewart and Chief Communications Officer, Sarah Courtney came to visit us in Michigan in early October. At a hybrid event

held in Plymouth, members from 11 Leagues were there, and almost all other Leagues had members joining via Zoom. Celina gave <u>an inspiring address to</u> our Michigan Leagues, especially thanking all the members who had been working on voter guides, candidate forums, voter registration drives and all things voter service. We hosted a dinner for League leaders and members in the evening, and then Celina and Sarah joined us in Lansing for an in-person board meeting the next day. A lot was packed in to their 24-hour visit, and we were continually proud to talk about all of the work YOU are doing to educate Michigan voters and protect our democracy.

We're only weeks away from the election, but we know that county certification is a critical piece of the League's work. Our Board of Canvassers observation program is recognized nationally by pro-democracy groups, and we've had numerous contacts from groups wishing to duplicate our program or to help in counties where there is no League. The BOC SignUp Genius link

will be available on or before October 25th. Watch for a special League Links "In-Betweener" in a few days which will provide all the details you need to participate. We're counting on you!

We want to extend special thanks to two groups of LWV members: The statewide VOTE411/Voter Guide team did an amazing job with their work and met all the tight deadlines to publish/go live before the first absentee ballots went out. We are grateful to Carolyn Vertin and Jane Poczatek who handled VOTE411, and to Sara Weertz who produced the 40-page print voter guide. And thank you to Judy Florian who oversaw both projects with patience and commitment.

Voter Service Updates

Local League Supplemental Guide Grant Funding

For those local Leagues who produce a supplemental guide for the November election, a maximum of \$1,000 is available to assist with your expenses. To receive reimbursement, you must do the following:

- Complete the Local League Supplemental Voter Guide Survey, available at this <u>link</u>.
- Complete the LWVMI Expense Voucher, available at thislink
- Submit receipt(s) with expense voucher to Judy Florian at <u>jflo@comcast.net</u>.

Please do not submit to the LWVMI office.

The deadline to submit the above forms is November 15, 2024.

Get Out the Vote (GOTV) Postcard Reimbursements

For those local Leagues who participated in the GOTV postcard project, don't forget to submit your receipts and expense voucher to Judy Florian at <u>jflo@comcast.net</u>. **Please do not send to the LWVMI office.** The maximum reimbursement amount is \$1,000 for printing and postage. The

reimbursement form can be found on the LWVMI website at this <u>link</u>. **The** deadline for reimbursement is November 15, 2024.

Secure and Accurate Elections

Promote the Vote (PTV) has created a Secure and Accurate Elections page on their website: Michiganvoting.org. This page highlights Michigan's election system, which has many checks and balances to ensure the results accurately reflect the will of the voters. However, most Michigan voters aren't fully aware of what goes on behind the scenes to ensure that only eligible voters are registered and cast a ballot–and that the votes on each ballot are recorded accurately.

The website includes the following information and goes into further detail on each topic:

- Secure and accurate voter rolls. Before a voter is registered, election officials verify their eligibility, their identity, and their residency. And election officials work year-round to ensure that Michigan's voter rolls remain accurate.
- Secure and accurate voting. Before a voter is issued a ballot, election officials verify their identity and ensure that they have not already voted. They also ensure that drop boxes are secure and that chain of custody for ballots returned via drop box is meticulously maintained. And before an absentee ballot is counted, election officials once again verify the voter's identity.
- Secure and accurate counting. Michigan's elections use paper ballots and secure, tested optical scan machines.
- Secure and accurate results. County and state boards of canvassers review records and certify the results. And post-election audits further confirm the accuracy of those results.

I strongly encourage you to share this information with those in your communities and put the link on your websites. Getting the word out about our secure and fair elections is critical, especially during these times of disinformation. You can access the page at this <u>link</u>.

Important Election Information

Monday, October 21 is the last day to register to vote, or to update your registration, <u>online</u> or <u>by mail</u> for the November 5 General Election. Starting Tuesday, October 22 (through 8 p.m. on Election Day), you can only register to vote by visiting your city or township clerk's office, completing a registration application, and providing proof of residency.


Proof of residency is a document with both your name and the address where you currently live. You can use any of the following:

- A Michigan driver's license or state ID card
- A utility bill
- A bank statement
- A paycheck
- A government check
- Any other government document

For most voters, Tuesday, October 22 is the last day your absentee ballot should be mailed. Starting Wednesday, October 23, it is recommended you return your ballot in person to your <u>city or township clerk's office</u> or satellite

office, or to a secure drop box in your city or township to ensure your clerk receives your ballot by 8 p.m. on Election Day (November 5). You can find the drop box(es) in your city or township by going to <u>mi.gov/vote</u> and clicking on "*Your Voter Information.*"

Remember: the absentee ballot deadlines are different for voters who are serving in the military or living overseas–their ballots must be postmarked by Election Day (November 5) and received within 6 days of Election Day (November 12th–November 11th is a holiday) in order to be counted.



Early Voting Begins Soon

The Michigan Constitution now allows at least 9 days of early voting in Michigan. For most jurisdictions, this period begins on Saturday, October 26 and ends on Sunday, November 3. In Detroit, early voting began Saturday October 19. There are also other areas that offer early voting beyond the 9 days. Early voting is an excellent way for voters to cast their ballots before Election Day. We encourage voters to use this flexible option to vote based on what works with their schedules. We hope you will promote early voting in your communities. The location of early voting sites is available on Michigan.gov/vote or from local clerks.

November 5th General Election Worker Survey

Don't forget to complete our Election Worker Survey if you plan to serve as a poll worker/election inspector, poll watcher or poll challenger. This provides valuable data for our grant reporting. You can access the survey at this <u>link</u>.

Advocacy Update

STATEWIDE ADVOCACY ZOOM: The Advocacy Committee will host a statewide advocacy committee Zoom meeting to highlight the legislation that LWVMI hopes to move during the lame duck session. All members are invited to attend the meeting on **Wednesday**, **November 13, at 7 p.m.** Click <u>HERE</u> to sign up. After registering, you will receive a confirmation email containing information about joining the meeting.



LEGISLATION: The committee voted to recommend support for House Bills 5957 and 5958, a bipartisan plan proposing to amend Michigan's Clean Slate expungement process to simplify the petition process and eliminate unnecessary delays. The bills are assigned to the House Committee on Criminal Justice. The committee also supported House Bills 5450 & 5451 that require schools to distribute information on gun safety assigned to the House Education Committee; and SB 857 that establishes in statute a gun ban in certain state buildings assigned to the House Committee on Civil Rights, Judiciary and Public Safety.

At this time, neither the Michigan House of Representatives nor the Senate are considering any legislation that LWVMI is following.

ChapterSpot Trainings will begin on November 11. Your League ChapterSpot contact has received a message about the trainings that will be offered to show how to implement and use ChapterSpot, the new membership platform that LWVUS will launch in the new year. You can access the training schedule and register for sessions at the ChapterSpot Resources page at lwv.org. Scroll down to League Leader Training. Read the descriptions of the training topics for each of five groups: Membership Chairs; Treasurers; Roster Managers; Webmasters; and Presidents. Not all Leagues use these "role" titles, but the training descriptors will let you know which session will offer information you want and need to know. There will be five training session for each group spread across two weeks in November and three weeks in December. Times of day and days of the week for the training sessions vary. Registration for a session of choice can be done by clicking on the group name. If none of the live training session can work, there will be recordings of a session from each group. The recordings will be available at the same ChapterSpot Resources location.

League of Women Voters Lake Michigan Region Annual Meeting and Conference

Michigan is hosting the 2024 Annual Meeting & Conference which will be held in Manistee, Michigan, October 25-27, 2024.

Activities include educational sessions, catered lunch and annual meeting at West Shore Community College Riverfront Learning Center (Downtown Manistee and just a short walk or drive from the hotel), Private dinner at <u>The</u>

<u>Blue Fish Kitchen + Bar | Manistee MI</u> with guest speaker J. Carl Ganter, award winning photographer and co-founder of <u>Circle of Blue | Water</u> <u>Reporting, Data & Convening</u>.

Optional fieldtrips: Friday afternoon guided Arcadia Marsh tour (3/4 mile fully accessible boardwalk) and Sunday Manistee Riverwalk.

Conference registration \$115, virtual option available, plus educational presentations will be recorded for rebroadcast. All Leagues that have paid dues for the **2024-25** fiscal year are eligible for one voting delegate to our annual meeting. Know a Voter Who Needs a Ride?

The rideshare service Lyft is offering 50% discount up to \$10 on a ride to the polls on election day. The voter should use the code VOTE24. Additionally, LWVMI has been given 50 codes

for **free** rides to the polls on election day. There are restrictions of course: the value of the free ride can't exceed \$25, and only one code can be used per voter. Disabled voters can use 2 codes. If you want any of the **free** codes, please contact <u>Paula Bowman</u>.





Flint Area Holds Mock Vote

At the Ruth Mott Foundation Applewood Fall Festival, the LWVFA conducted a mock election to help young people learn about the voting process. Visitors were issued a ballot and were asked to vote for their favorite fruit! The choices were apple, banana, cherry & strawberry. The ballots had a circle to fill in, the name of the fruit, and a picture for those little ones not yet able to read. The voters were then sent to a table where privacy booths were set up. After they marked their ballot (that indicated vote for only 1), they placed it in a ballot box and received an "I Voted Today" sticker. 600 total votes were received, and strawberry won the vote with 196 votes. There were 38 overvotes and 1 write in (mango)! The activity was well received by families and all the League volunteers had a great day!

Local League Spotlights



LWV of Detroit partnered with the Detroit Public Library for a webinar on Michigan Environmental Policy on October 8th. The presenter was Ellen Vial of the Michigan Environmental Council who talked about how the November election results could shape environmental policy in Michigan for the next few years.

LWV of Greater Grand Rapids Area co-sponsored a program with The Greater Grand Rapids Women's History Council and the Gerald R. Ford Presidential Museum titled, "*Grand Rapids Champions Women's Rights: LWV, Betty Ford & the ERA.*" Dr. Liette Gidlow of Wayne State University explored the development of the LWV in Grand Rapids and First Lady Betty Ford's historic membership during the fight for the ERA.

LWV of Delta County partnered with the Friends of the Escanaba Public Library to add a voting component to the Friends' Annual Back-to-School Open House. Children under 12 years old voted on two items and those older than 12 voted on three items. The item from each age group with the most votes will be purchased by the Friends and added to the Children's Room and Teen Area at the library. League members assisted with the voting. The Delta City Clerk loaned the privacy voting partitions and application to vote forms.
