#### FAQs on Unite and Rise 8.5

#### What is it?

Unite & Rise 8.5 is a LWV movement to build a force of 8.5 million individuals to unite and rise up against the anti-democratic actions of this administration.

#### Where did the 8.5 come from?

This is the estimated number of voters it would take to bring about change through nonviolent protest. This is based on this finding from the Carr-Ryan Center for Human Rights: "Nonviolent protests are twice as likely to succeed as armed conflicts...and those engaging a threshold of 3.5% of the population have never failed to bring about change." 8.5 million is the estimated 3.5% of eligible voters.

#### What anti-democracy issues is LWV most concerned about?

- The anti-voter SAVE Act, which is now in the Senate.
- Financial gutting of crucial programs like Medicaid.
- Illegal deportations and violation of immigrant rights.

## What can we do as League members?

- Subscribe to LWVUS and LWVMI social media platforms and share posts.
- Make sure your friends and family know about the prohibitive Documentary Proof of Citizenship (DPOC) that will be required if the SAVE Act is signed into law or if Michigan voters support the 2026 ballot proposals requiring DPOC in all elections.
- Call or email your congressional (and state) representatives and let them know your opposition to the reduction of Medicaid support for lowincome Americans as well as your disgust with the violations of immigrants' rights.
- Read more on the Unite & Rise 8.5 Playbook. Links to materials are on the LWV Only page of LWVMI's website. Ask your president for the password.
- Attend one of the monthly training sessions offered by LWVUS to engage more voters. (Note – Denise and Paula are featured on the July 23<sup>rd</sup> training).

# How do LWV members maintain our non-partisanship while working on Unite and Rise 8.5?

We are non-partisan, not neutral or silent. When democracy itself is under threat, voter access is restricted, or misinformation spreads, the League has a responsibility to speak out clearly and forcefully. Our nonpartisan commitment means the League acts based on our policies and principles, not because of political parties.

We advocate for fundamental rights and freedoms regardless of which political party is in power or which officials are responsible. Focusing on our issues, not affiliations, strengthens our voice and credibility. We hold true to our mission without being beholden to any political agenda.

# **Voter Service Updates**

### **VOTE411 Follow-Up from Convention**

We had very useful discussions at the LWVMI Convention regarding candidates who knowingly report false information on VOTE411.

Megan Brown, VOTE411Senior Manager from LWVUS, confirmed that the **VOTE411 ballot pages** include the following disclaimer:

The League of Women Voters does not support or oppose any candidates or parties. All responses come directly from the candidates and are unedited by the League. The League does not certify the accuracy of the candidate's statements. The League reserves the right to remove or redact portions of candidate responses that violate state or federal law or the voter guide rules that are provided to all candidates before participating in the voter guide.

LWVUS also suggests that local Leagues include the following language in their candidate invitations to indicate what is and is not allowed in their responses. LWVMI is encouraging our local League administrators to include this language.

By participating in this activity sponsored by the League of Women Voters, a candidate agrees to the following:

- I will not upload false or defamatory words tending to harm another's reputation, business, or means of livelihood.
- I will not upload copyrighted or other legally protected material without the permission of the owner of such material
- I will not upload statements that include an incitement of violence, threats to any person or group of people, obscenities, or slurs.
- I will not upload any knowingly false information.

If you are in violation of these rules, you will be given the opportunity to update your response to comply with these rules. If you fail to comply, all or part of the statement(s) will be redacted.

# **Advocacy Update**

#### **Federal:**

**SAVE Act**: The League continues to monitor the bill that has passed the U.S. House of Representatives and is now in the U.S. Senate. LWV has an action alert available <a href="here">here</a> so that you can urge our MI Senators to vote no on the SAVE Act.



"A Big Beautiful Bill": The Senate Finance Committee has released its new version of the House passed bill. There are changes, but it continues to cut Medicaid and makes changes in the Affordable Care Act. Able-bodied adults without dependents can work, participate in a work training program, enroll in school, or volunteer for 20 hours per week to receive Medicaid. The changes in the Affordable Care Act could result in 4 million out of 25 million people losing coverage. The bill is available <a href="here">here</a>. LWV has an action alert to urge U.S. Senators not to cut Medicaid, and you can take action <a href="here">here</a>.

#### Michigan:

So far, the Republican-controlled House of Representatives has passed approximately 140 bills to the Senate. The Democratic-controlled Senate has passed approximately 100 bills to the House. However, only 5 bills have passed the House and Senate and been signed by the Governor into law.

Medicaid Budget: LWVMI joined the Protect MI Care coalition of over 260 organizations working to maintain funding for Medicaid. One in 4 Michiganders are in the Medicaid program, approximately 2.4 million people. The Michigan Department of Health & Human Services released this report highlighting the Medicaid program and the impact of potential cuts. There will be a vigil at the State Capitol on Wednesday, June 25, from 6:00 p.m. to 7:30 p.m. You can sign up to attend here. You can learn more about the coalition here.

**School Aid Budget:** The Michigan Senate has passed its appropriation bills to the House. The House has passed its appropriations bills for K-12 education and higher education and sent them to the Senate. Negotiations are taking place, and we may see passage of education budget bills by July 1 and others may wait until this fall. The new fiscal year begins October 1, 2025. LWVMI voted to oppose the House-passed school aid budget bill, HB 4577, because it contains \$40.8 million in funding for nonpublic schools. For more detailed information, go to School Aid.

Ballot Proposals: The State Board of Canvassers will meet Friday, June

27. The agenda is not available yet, but we expect they may consider the petition and announcement summary language for Rank MI Vote (Ranked Choice Voting) and Invest MI Kids (raises taxes on people making more than \$500,000 annually earmarked for education). To date, the Board has approved AxMITax to eliminate property taxes, and Protect Voters' Rights which would require verification of citizenship to register to vote. Also, a referendum submitted to the Board of State Canvassers by Voters to Stop Pay Cuts would allow voters to decide whether to keep PA 1 of 2025 that raises the minimum wage to \$15 an hour by 2027 and increases the tipped minimum wage from 38 percent of the regular wage to 50 percent by 2031. We have a list of ballot proposals submitted to the State Board of Canvassers on our website.

House v Benson Judge Sima Patel of the Michigan Court of Claims ordered the MI House of Representatives and the Department of State to file briefs by the end of June and early July in the ongoing dispute about election training materials. The MI House filed the lawsuit alleging the Secretary of State failed to comply with a subpoena issued to obtain election training materials. "Since the beginning of this saga, Secretary Benson has asked lawmakers to let a court review their request for sensitive election information that, in the wrong hands, would compromise the security of our election machines, ballots and officials," said MDOS spokesperson Cheri Hardmon.

As I end my term as Vice President for Advocacy, I want to thank our hard-working advocacy committee and LWVMI Board of Directors! I look forward to working with the new Vice President for Advocacy, Sandra Sorini Elser.

# **Email Safety Tips**

NEVER click on a link or an attachment in an email unless you are absolutely sure of its safety.

- Look at the actual email address, which is sometimes hard to do on a phone, not the alias
- Are you expecting the email?
- If in doubt, delete the email. It can be replaced if necessary.
- Do an internet search to find the necessary site. Consumers Energy sends me an email with a link to my bill; I don't use the link; I go to their website, sign into my account, and bring up the bill.

Viewing the email content is typically safe. Interacting with the email content (opening files, clicking on links) is not safe.

# Save the Date Renewable Energy in the UP and All of Michigan September 24 at 7pm via Zoom


Please save the date for a League of Women Voters of Michigan educational presentation on September 24 at 7pm via Zoom on Renewable Energy in the UP and All of Michigan.
