# President's Message - Unite and Rise 8.5, and Petitions

#### Presidents' Message

Transitions are times of challenges plus new and energizing ideas. A convening of LWV leaders from all but a few states took place in Washington DC in late June. LWVMI was represented by newly elected co-president Lynne Kochmanski, co-president Denise Hartsough, and newly elected VP of Advocacy, Sandra Sorini Elser. The weekend was an opportunity to network with state leaders to discuss everything from finances to challenges and victories. Compared to some states, Michigan has more laws and constitutional provisions that embody LWV values. However, our state has recently seen several proposals that would curtail our existing voting rights and which mirror what is happening at the federal level. The League is taking a stand and will push back against anti-democracy actions and policies everywhere they appear. This was the message loud and clear we took away from Council.

#### **Unite and Rise 8.5**

With the rolling out of Unite and Rise 8.5 by LWVUS there will be opportunities for local Leagues to engage in this national mobilization campaign. Our state League is creating a Mobilization Network composed of

local League representatives. It will meet twice each time a new Unite and Rise 8.5 Playbook is released, once at the start of the new Playbook and then halfway through the 90-day period assigned to each Playbook. The network will provide a place where local Leagues can share ideas, strategize, and exchange materials to better engage in Unite and Rise 8.5 at the local level. We ask each local League to designate one representative for this network. More information will be sent to all local League network representatives in the next couple of weeks. The next Playbook will be released before August 1st.

#### Petitions, Petitions, and more Petitions

Voters are very confused by petitions, especially when there are so many of them! Currently we are following 7 petitions and 1 ballot proposal. To help educate voters about all the petitions out there we are creating a Know What You Sign flyer which local Leagues may use at tabling events. Of the 7 petitions, currently 3 would require Michigan voters to show documentary proof of citizenship. There is no information about which of these will be circulated or when. See our Proposal Tracking document for specific information on each petition.

As the summer winds down, stay engaged and informed, and also enjoy the rest of the season!

# **Voter Service Updates**

### **August Primary Elections**

Elections will be conducted in 129 jurisdictions in 51 counties on August 5<sup>h</sup>. Although not required, 12 jurisdictions will also offer early voting sites.

Although this is an 'off-election year', local elections can be more important than those at the state or national level. The ballots will include local races (mayor, city council, etc.) In some communities, there may also be ballot proposals. Our VOTE411 admins are working diligently to provide candidate information for voters in their communities.

We encourage League members to participate in the election process by serving as poll workers, poll challengers or poll watchers.

If you're conducting candidate forums, don't forget our resources, including the LWVMI Candidate Forum Guide and sample questions. These are available on our website in the LWV Only section. Please contact me or a Local League President/Leader for the password.

Promote the Vote (PTV) also has a wealth of election information available at michiganvoting.org, including deadline dates, absentee voter ballot options and much more.

NOW	Request an absentee ballot
JUNE 26	First day that you can vote in person with an absentee ballot at your local clerk's office
JULY 21	Last day to register to vote online (after July 21, you'll need to register in person at your local clerk's office)
JULY 22	Last day to drop your ballot in the mail (after July 22, we recommend returning your ballot in person)
AUGUST 4 @ 4pm	Deadline to vote in person with an absentee ballot at your local clerk's office, if you're already registered to vote where you live (after that, you must vote at your polling place on Election Day)
AUGUST 5	Election day! Polls are open from 7am until 8pm. If you need to register, you can register at your local clerk's office until 8pm

# **Board of Canvassers Observation - August 5 Election**

Observing the Board of Canvassers (BOC) has become a signature piece of the League of Women Voters in Michigan. Our democracy partners depend on the eyes and ears of League members to report on the BOC's work and/or the areas of concern at these public meetings.

We will need your help for the August Election. There will be 129 jurisdictions in 51 counties conducting elections on August 5. (For more details, here is the list from the Michigan Department of State: <u>Jurisdiction Elections for August 2025</u>.) Some County Boards will take only 1-2 days to certify, while others will take the entire 14 days (including weekends). The more populous the county, the longer the canvassing process. There are a lot of 2-hour shifts to fill!

watch the League's <u>training video</u> with election attorney Mark Brewer, which was conducted live on July 22, 2024.



# Advocacy Update LWVUS Federal Judiciary Position Adopted June 2025





The Federal Judiciary position was adopted using the long-standing League practice of grassroots study to arrive at member understanding and agreement. 321 Leagues representing 45 states and the District of Columbia participated in the study.

Prior to the local Leagues' consensus meetings, the LWVUS study committee compiled extensive research papers and held informative panel discussion sessions on the 4 main issue areas surrounding the Federal Judiciary:

- Transparency
- Ethics
- Accountability
- Independence

Local Leagues from all over Michigan participated in the study last winter and spring and submitted their consensus reports in April of 2025.

The Federal Judiciary position is now part of the League's official public policy positions and is available as a supplemental PDF document, which can be found here.

The Federal Judiciary position will be folded into the next edition of Impact on Issues. Until that time, Leagues may refer to the document in the link above

# September 24 at 7pm via Zoom


Please save the date for a League of Women Voters of Michigan educational presentation on September 24 at 7pm via Zoom on Renewable Energy in the UP and All of Michigan.
