

#### POSSIBLE STATEWIDE BALLOT PETITIONS NOVEMBER 2026

1. MI Constitutional Convention - Required by MI Constitution to be on ballot every 16 years.

"A PROPOSAL TO CONVENE A CONSTITUTIONAL CONVENTION FOR THE PURPOSE OF DRAFTING
"A GENERAL REVISION OF THE STATE CONSTITUTION

Shall a convention of elected delegates be convened in 2027 to draft a general revision of the State Constitution for presentation to the state's voters for their approval or rejection? "

No signatures required- will be on the November 2026 ballot.

## 2. AxMITax – a constitutional amendment

100-word summary approved by the Michigan Board of State Canvassers on 12/2/24.

"Constitutional amendment to: prohibit real and personal property taxes, currently the primary funding source for counties, municipalities, schools, community colleges, parks, and voterapproved bond repayment; increase portion of state sales tax redirected to cities, townships, and villages from 10% to 13.3%, and from 0% to 6.67% for counties; shift 10% of state income, marihuana, alcohol, and tobacco tax revenue to local governments; allow use of this revenue only for listed essential government and infrastructure services but not for schools, community colleges, parks or local government services; require 60% voter approval for local tax increases; require 2/3 vote of Legislature for tax increases greater than 0.1% over 5 years."

# 3. Protect Voters' Rights – a constitutional amendment

100-word summary approved by the Michigan Board of State Canvassers on 4/18/25.

"Constitutional amendment to: require Secretary of State verify citizenship of all registered voters, document citizenship, remove non-citizens using governmental records, and track separate eligibility requirements for federal and state/local elections; prohibit counting ballots from voters with unverified citizenship unless voters show documents to Secretary within 6 days post-election; for new registrations, require proof of citizenship by showing birth certificate, passport, and/or other documents; eliminate affidavit alternative for voters without photo-ID; require photo-ID, or driver's license or partial social security number to vote absentee; require state-funded hardship program for obtaining required documents; subject violations to \$1,000 fine and/or up to 5 years imprisonment."

**4.** Americans for Citizens Voting – Michigan - Version 1 - a constitutional amendment 100-word summary approved by the Michigan Board of State Canvassers on 5/16/25.

"Constitutional amendment to: require Secretary of State verify citizenship of all registered voters, document citizenship, remove non-citizens using governmental records, and track separate eligibility requirements for federal and state/local elections; prohibit counting ballots from voters with unverified citizenship unless voters show documents to Secretary within 6 days post-election; for new registrations, require proof of citizenship by showing birth certificate, passport, and/or other documents; eliminate affidavit alternative for voters without photo-ID; require photo-ID, or driver's license or partial social security number to vote absentee; require state-funded hardship program for obtaining required documents; subject violations to \$1,000 fine and/or up to 5 years imprisonment."

## 5. Voters to Stop Pay Cuts – a referendum on PA 1 of 2025

100-word summary approved by the Michigan Board of State Canvassers on 6/27/25.

"Referendum to repeal Public Act 1 of 2025, which amended the Improved Workforce Opportunity Wage Act. A repeal of PA 1 would decrease the minimum wage from \$13.73 to \$13.29 (2026) and from \$15 to \$14.16 (2027), with annual inflation-based increases thereafter; increase tipped worker wage to 48 percent of the full minimum wage in 2025, 60 percent in 2026, 70 percent in 2027, 80 percent in 2028, 90 percent in 2029 and 100 percent in 2030; and eliminate civil fines for employers failing to pay minimum hourly wage. This referendum petition would suspend PA 1 of 2025 and place it on the ballot for voter approval or rejection."

### 6. Rank MI Vote - a constitutional amendment

100-word summary approved by the Michigan Board of State Canvassers on 6/27/25.

"Constitutional amendment to: require ranked choice voting (RCV) for federal offices, governor/lieutenant governor, attorney general and secretary of state, allowing voters to numerically rank candidates by voter preference starting in 2029; count votes in rounds eliminating lowest ranked candidate and reallocating their votes to remaining ranked candidates until candidate with most final round votes is declared the winner; allow voters to rank at least four more candidates than positions to be nominated/elected unless insufficient number of candidates; authorize local jurisdictions to adopt use of RCV in local elections; move August primary to June or earlier in even year elections; require legislative funding and implementing legislation."

7. Americans for Citizens Voting – Michigan - Version 2 - a constitutional amendment 100-word summary approved by the Michigan Board of State Canvassers on 7/10/25.

"Constitutional amendment to: require citizenship verification for all voters through statewide program, document submission, or provisional voting; require removing noncitizens after notice and 45-day rebuttal; require proof of citizenship by showing birth certificate, passport, and/or other documents; track separate federal and state/local election eligibility requirements; beginning 11/2/2027, prohibit counting ballots from voters with unverified citizenship unless documents shown to election administrator within 6 days post-election; eliminate affidavit alternative for voters without photo-ID; require photo-ID, or driver's license or partial social security number to vote absentee; require state-funded hardship program for obtaining required documents; subject violators to \$1,000 fine and/or up to 5 years imprisonment"

### 8. Invest in MI Kids – a constitutional amendment

100-word summary <u>was not</u> approved by the Michigan Board of State Canvassers on 7/31/25 Group plans to use this wording that was approved by the Michigan Board of State Canvassers and then rescinded by the Board. That language is below.

"Constitutional amendment to: add, beginning in 2027, an additional 5% tax on annual taxable income over \$1 million for joint filers and over \$500,000 for single filers. This tax is in addition to existing state income taxes, and is to be deposited into the State School Aid Fund and required to be used exclusively on local school district classrooms, career and technical education, reducing class sizes, and recruiting and retaining teachers; and subject funds to annual audits."

# 9. Michiganders for Money Out of Politics – an initiative petition

100-word summary approved by the Michigan Board of State Canvassers on 8/22/25 "Initiation of legislation to: prohibit regulated electric and gas utilities, contractors with over \$250,000 annually in government contracts, and people and organizations with substantial connections to these utilities/contractors from making direct or indirect campaign contributions to those who run for or hold offices that impact them; expand campaign finance laws and restrictions that regulate spending on political communications, including laws that require disclosing donor information, to apply to communications clearly identifying candidate or ballot questions, even if they do not expressly advocate voting for/against them; expressly apply the law requiring disclosure of who paid for political communications to internet political communications."
