#### Happy September, League Members!

Many thanks to all the Leagues who participated in National Voter Registration Day on September 16th! It was great to see our local Leagues highlighted on the LWVUS interactive map for that day. We appreciate you signing up, so Michigan could be recognized! October also brings multiple Civic Holidays leading up to the November election. We know local Leagues are hard at work preparing voter guides and VOTE411, candidate forums, along with information about absentee ballots, polling places, early voting, and more.

#### Please consider engaging in:

- October 6 10: <u>National Voter Education Week</u> | Give voters the tools they need to cast their ballots with confidence.
- October 28: <u>Vote Early Day</u> | Make sure communities have the tools to vote early!

• November 3: <u>Election Heroes Day</u> | Thank election workers in your community. They are the heroes who ensure our elections run safely.

LWVMI just released an educational PowerPoint for presentation by local Leagues to inform your communities about the statewide ballot proposal petitions. A tutorial on "Know What You Sign" is set for Monday, September 29 at 7pm. See the Voter Service article below for details.

Remember to keep educational forums separate from League advocacy. If advocating against signing the petition requiring Documentary Proof of Citizenship (No Red Tape For MI campaign), do so separately from voter services work. The DPOC petitions are out there – League members have run into circulators, paid by the signature, who are misleading the public into signing.

Stay tuned for LWVMI's approach to advocacy on other ballot proposal petitions. Until LWVMI finalizes that strategy, local Leagues should refrain from advocating on any petition except those involving Documentary Proof of Citizenship. Of course, individual members may support or oppose petition campaigns as individuals, just not in the name of the League.

#### **Voter Service Updates**

#### **Know What You Sign Campaign**

We are pleased to announce our Know What You Sign Campaign, which is an opportunity for our local Leagues to educate their communities on the potential ballot proposals for 2026. LWVMI has created a Power Point presentation and script for local Leagues to use. This presentation is for educational purposes only, with no mention of advocacy for or against signing any of the petitions. A second presentation, under development, will address the League's advocacy positions related to the petitions/ballot proposals.


Local Leagues will receive a grant of \$200 for the first presentation, and \$100 each for up to two subsequent presentations. Maximum grant funds per League or Unit are \$400. Payments will be made in March 2026 if the following conditions are met.

- Eligible presentations must be made between October 1, 2025 and February 28, 2026.
- Presentations must be to the community, and may be either in person or virtual.
- If possible, we ask Leagues to record at least one presentation for viewing on your YouTube Channel or website.
- Consider partnering with other organizations in your community (ACLU,

- NAACP, etc.) to expand your reach.
- Seek out local community venues for your presentations (libraries, churches, schools, colleges, clubs, etc.)
- The League or Unit must report its presentation(s) using the KWYS Report Form, which is on the LWVMI website under Members and LWV Only. (Contact your president/leader if you need the password.)
- This grant money comes from the LWVUS Education Fund, so it is important that the presentations be purely educational-with **no** advocacy.
- Because LWVMI needs to report to LWVUS EF about the presentations, the KWYS Report Form requests data and information about the presentations.

If your League offers more than 3 presentations, we ask Leagues to please complete the KWYS Report Form so LWVMI can send full information on the impact of the grant to LWVUS EF.

We will offer a 'run through' of the PowerPoint and script on Monday, September 29 at 7pm on Zoom. We strongly encourage local Leagues to either attend the session or view the recording before beginning to give presentations in communities. The recording will be available on the LWVMI website under Members and LWV Only. You may register for the September 29th session HERE.



#### **Permanent Mail Ballot List Text Banking Project**

LWVMI will participate in a text banking project with RelaA2ve, the organization we partnered with in 2024. The focus of this project is to contact 640,000 voters who voted in 2020 but did not vote in 2024. The goal is to urge these voters to sign up for the Permanent Mail Ballot list. They will automatically receive their absentee ballot, which may encourage them to vote in 2025 and 2026. Currently, 16 local Leagues have signed up to participate. These Leagues are meeting with Bob Chunn, our representative from RelA2ve, to learn the process and develop their messages. The messages will also contain the local League's logo—having the League's brand on these texts adds credibility to the message.

#### **Naturalization Ceremony Changes**

For decades the LWV has offered voter registration to new citizens at naturalization ceremonies. However, new guidance from the US Citizenship and Immigration Services (USCIS) bars groups like the League from providing voter registration at administrative naturalization ceremonies. This change in USCIS policy makes it harder for new citizens to register to vote

and is yet another attack on the immigrant community. Our democracy is stronger with the voices of new citizens. If your League is involved in voter registration of newly naturalized citizens, please check to see if you may continue (judicial ceremonies) or not (administrative ceremonies). #### LWV is Sponsor of No Kings Rally October 18

LWVUS is one of the sponsors of the No Kings Rally on Oct 18 - participate! Here is the latest guidance from LWVUS regarding the rally:

"LWVUS is joining No Kings 2 as a national partner on Saturday, October 18. LWVUS has decided to become an official partner for this day of mobilization to stand in solidarity with partners and stand up against hate and authoritarianism. I'll be attending a No Kings event in my own community. The League has consistently and boldly spoken up in the face of rising authoritarianism. This is an opportunity to put words into action and show up in defense of democracy and as an effective ally. We encourage Leagues to lean in locally and participate in activations with partners on the ground in a nonpartisan manner. We understand that we cannot control how other partners show up, and participating in any event comes with some risk. For Leagues who decide to mobilize for No Kings, please utilize our protest safety guidance and "How to Organize a Rally in 8 Steps" resource on the League Management Site. If representing the League or wearing LWV shirts (which we encourage), please use good judgment when creating signs and participating in nonpartisan chants. The national staff will have additional guidance in the weeks ahead."

#### **State Budget Standoff**

The state budget for fiscal year 2025-26 begins on October 1, 2025. Governor Gretchen Whitmer presented the Executive Budget to the Michigan Legislature on February 5. The Executive Budget is available <a href="https://executive.new.org/new.new.org/">here</a>.

The Michigan Senate passed its budget bills on May 13. A summary of the 20 bills is available here.

The Michigan House of Representatives passed it final budget bill on August 28. A summary of HB 4706 is available <a href="here">here</a>. Three other education bills were also passed by the House, HB 4576, HB 4580 and HB 4577.

The differences between the House passed and Senate passed budget bills are immense. The House passed budget totals \$78.5 billion, and the Senate passed budget totals \$84.5 billion. Governor Whitmer held a <a href="mailto:press">press</a> conference on September 16 and urged the Senate and House to work together to get her a budget as soon as possible to prevent a government shut down.

Some of the Michigan Departments released information about the potential impacts if the House Republican budget bills are adopted. The Secretary of State <u>noted</u> she would have to lay off more than 400 employees and to close 10% of the branch offices. The Michigan Department of Health and Human Services Hertel <u>said</u> the House passed budget would eliminate more than 1,600 positions and result in significant service reductions through loss of programs. House Appropriations Chair Ann Bollin <u>said</u> they passed a responsible, balanced state budget that "reins in wasteful spending and makes historic investment in the priorities of Michigan families."

The League of Women Voters of Michigan held the LWVMI State Budget Forum on September 16 moderated by LWVMI Vice President for Advocacy, Sandra Sorini Elser. Our speakers included Arnold Weinfeld, Associate Director, Institute for Public Policy and Social Research at MSU, Rachel Richards, Director of Fiscal Policy and Government Relations at Michigan League for Public Policy, and Robert Schneider, Senior Research Associate at Citizens Research Council of Michigan.

As we await action in Michigan, we are also watching to see what will happen to the federal budget that also needs to be passed by October 1.

The Michigan 2023 Clean Energy and Jobs Act promises 100% clean energy by 2040, and 60% Renewable Energy by 2035. Join us as we explore how Michigan can get there, and what challenges there are for Michigan's Upper Peninsula.

Our speaker will be Douglas Jester, Managing Partner of 5 Lakes Energy. Douglas is a well know speaker specializing in economic analysis and modeling for energy policy and has provided expert witness testimony before utility regulatory commissions.
