
President's Message

Voter Service Updates

Project Manager Opportunity

LWVMI is seeking a Project Manager to coordinate the Board of Canvassers Observation Program for the 2026 election cycle, building on the successful model used since 2022.

The Project Manager coordinates all aspects of the program: training, materials, scheduling, communication with local clerks, communication with League leads and volunteers, data collection, shift report monitoring, and final reporting.

The Project Manager will also serve as liaison with the VOTE411 Director and the printer to edit/finalize the print Voter Guide. The Project Manager is an independent contractor paid from May-December 2026. For more information, please contact Judy Florian, VP for Voter Service.



Accessibility Audit Help Needed

Detroit Disability Power (DDP) is seeking volunteers to support accessibility audits in preparation for the 2026 elections. Audits will be conducted in both August and

November, with the goal of completing as many audits as possible statewide. DDP will provide instruction that includes:

- Auditor training
- An overview of the rights and responsibilities of election challengers (including credentials that allow access to designated areas within polling locations)
- Training on completing the audit survey

The training takes approximately two hours and is required to ensure auditors are well prepared to provide accurate, reliable information. DDP will also supply audit-day materials and support so auditors can have their questions and concerns addressed during the process. Know What You Sign Presentations

To date, 14 local Leagues have delivered presentations in their communities—thank you for helping spread the word! There is still time to participate; the deadline for presentations is February 28.

To receive reimbursement, all local Leagues must complete the KWYS Report Form (at this [link](#)) for each presentation. Payments will be sent to local Leagues in March.

Please be sure you are using the current version of the presentation and script. These were both revised due to the pause in petition signature gathering for Rank MI Vote. If you don't have the updated materials, please be sure to contact Judy Florian.

New US Postal Service Postmark Rule

Some of you may have heard about the new United States Postal Service (USPS) rule and its potential impact on ballots. Under this new rule, which took effect December 24, 2025, mail might not receive a postmark on the day the postal service takes possession of the mail.

According to the USPS, the rule *does not change any existing postal operations or postmarking practices but is instead intended to improve public understanding of postmarks and their relationship to the date of mailing.*

In Michigan, Absentee Voter Ballots (AVB) must be received by the clerk by 8:00 p.m. on Election Day and therefore are not dependent on postmarks. This postmark rule will not affect most Michigan voters. It is always a best practice for voters to mail their AVB well in advance of the election (we emphasize no later than two weeks prior to Election Day) to ensure timely receipt and counting of the AVB. If there is concern that there is not enough time to mail an AVB before the election, voters are encouraged to return their ballot at a local drop box, deliver their ballot in person to their early voting site (if available), their polling place on Election Day, or to their clerk's office.

While [news stories](#) covering the issue have indicated that there will be an impact on voting, the **only** potential impact in Michigan will be for ballots under the Military and Overseas Voters Empowerment (MOVE) Act. MOVE ballots must be postmarked by Election Day and received by the clerk by 6 days after the election.

MOVE ballots and also mailed voter registration forms are areas where we are continuing to seek guidance. Stay tuned!

LWVUS Program Planning

LWVUS Program is the education and advocacy platform that League membership adopts at each biennial LWV National Convention. As shared in the [Leaders Guide to LWVUS Program 2026-28](#), the goal of the LWVUS Program Planning process is to achieve a collective agreement around how LWV will move our mission forward over a two-year period.

During January and February 2026, local leagues have been asked to schedule Program Planning meetings within their membership or board meetings and respond to the LWVUS online survey. Read the pdf of the [Program Planning Survey](#).

Local leagues will be asked to consider whether to adopt the New, Proposed Campaign – Women Defend Democracy: Democracy Under Siege. The campaign has six prongs:

- Voting Rights
- Election Protection
- Redistricting
- Individual Liberties
- Immigration
- The Presidency

Leagues will also be asked to consider suggested additions to the LWVUS public policy positions in [Impact on Issues](#). These proposals could take the form of a suggested study or concurrence with an existing position from a local or state league.

LWV Colorado and LWV Washington are asking local and state Leagues to recommend and adopt their positions by concurrence when completing the survey.

The two positions proposed for concurrence are:

- Concurrence with the LWV Colorado position on [Religious Freedom Study](#)
- Concurrence with the LWV Washington position on Protecting Immigrant Rights

LWVMI Advocacy Committee Report

In January the League of Women Voters of Michigan Advocacy Committee recommended, and the Board approved, the following actions:

JANUARY 11, 2026 - SUPPORT FOR DATA CENTER WATER RESTRICTIONS

LWVMI supports SB 761, 762 and 763, which would limit water withdrawals by data centers, require the MPSC to report on energy and water usage by data centers, and bar water utilities from passing on the infrastructure costs to accommodate data centers to residential customers.

JANUARY 11, 2026 - SUPPORT FOR FAIR CHANCE ACCESS TO HOUSING

The League supports HB 5355 and SB 738 which would prohibit landlords from requiring rental applicants to disclose criminal records on an application, require landlords to first evaluate rental applicants without information on criminal record, and require landlords to conduct an individualized assessment to withdraw an applicant's approval due to a serious felony conviction.

JANUARY 11, 2026 - "DPOC" PROPOSALS ARE BAD FOR VOTERS AND CLERKS

LWVMI joined other pro-voter groups urging Michigan local and county governments to resolve to oppose the Documentary Proof of Citizenship (DPOC) ballot proposals that would add unnecessary red tape and suppress citizens' right to vote. Read the letter [here](#).

Update January 14, 2026: On December 14, 2025, LWVMI DENOUNCED HOUSE APPROPRIATIONS COMMITTEE VOTE TO DISAPPROVE \$645 MILLION IN FUNDING FOR VITAL STATE PROJECTS AND PROGRAMS

Update as of 1.14.26: Michigan Attorney General Dana Nessel issued a formal opinion concluding that a "disapproval" mechanism allowing one legislative committee to unilaterally terminate funding previously appropriated by the full Legislature and the Governor is unconstitutional. A video from Attorney General Nessel discussing the opinion can be found [here](#) and is available for public use. Attorney general opinions are binding on state agencies unless overturned in court. House Republicans have asked for a ruling that the action was constitutional. The matter is pending.

Youth Engagement Pass Through Grants for Local Leagues

LWVMI is providing an opportunity for local Leagues to encourage youth engagement in League voter service activities for the 2026 election year. Grant funds are available to offer honoraria to local youth (ages 16-25) who are interested in working with local Leagues.



We are asking local Leagues to submit a proposal on how they plan to engage youth. Proposals must be submitted **no later than April 30, 2026**. We will provide funds not to exceed \$1500*, so your proposal cannot exceed that amount. The proposal should contain specifics on what area(s) your League will focus for youth engagement and potential costs. The time period covered will be from May-November 2026. Your local League may determine other areas of youth engagement that are not covered in the above. We are open to any ideas that include voter service activities.

During this very important and critical election year, we encourage local Leagues to apply for this funding and actively engage youth in their communities. With the passage of MI PA 258 (requiring provision of voter pre-registration and registration information to students ages 16 and older in high schools), schools will be looking for ways to comply.

Membership Network Notes

January Meeting:

At the January 14 meeting we talked about what to store on our Google Drive, the concerns about membership, the upcoming February 11 program on immigration featuring Marcelo Betti of Immigration Law & Justice Michigan, and local League highlights. Michigan membership is down since last January, and Membership leaders highlighted a number of concerns with retaining members and noted ways to counter the downward trend.

Local League Highlights:

As usual, there is a lot going on around the state.

- Jackson Area League is working with the Girl Scouts of America (GSA) and other youth groups to collaborate on activities, such as the Friendship Tea, and to mentor youth.
- Saginaw County League is partnering with other groups and working on a youth project to get more youth involved with community government. In addition, they donate books to the county jail, especially for children of incarcerated women.
- Lansing Area League held a Pasta & Politics event with a speaker from a lobbying firm talking about state politics. It's held at a restaurant in a separate room with a limited menu, and many members enjoyed attending. They also have an upcoming meeting with a women's suffrage group, a planned volunteer fair, observer corps activities, and collaboration with groups in rural areas.

- Lenawee County League holds an annual White Elephant party for membership. They've recently moved the event from December to January since December is frequently too chaotic for many people. It's a great opportunity for fun and laughs.
- Leelanau County League holds new member meet & greets every other month to welcome new members and suggested it would be good to give books to disadvantaged families.
- Berrien/Cass Counties League held a holiday celebration at a local college with wine sampling & hors d'oeuvres.
- Flint Area League has been working on Observer Corps in the 4 counties they serve. They're also educating people on VOTE411, doing high school voter registration, and have planned a trip to a musical because we all need some fun things.
- Detroit League is holding a fund raiser at the Detroit Repertory Theatre, March 1, 2026, at 2pm; they're starting a new advocacy group; and in December they had a game night at a member's home.
- Copper County just finished their annual program planning. Their top issue is the jail that needs to be replaced. They are also looking at land use for data centers, death with dignity, and flock security cameras.
